COMMERCIAL GENERAL LIABILITY

This endorsement changes the policy. Please read it carefully.

AMATEUR ATHLETIC WAIVER, RELEASE OF LIABILITY AND CONTRACT THIS IS A LEGAL DOCUMENT WITH IMPORTANT CONSEQUENCES -- READ IT CAREFULLY BEFORE SIGNING

In consideration of being allowed to participate in any way in the athletic/sports program, and related events and activities of the **United States Amateur Soccer Association (the "USASA") and all its members**, the undersigned:

1. Agrees that prior to participating, he or she will inspect the facilities and equipment to be used, and if he or she believes anything is unsafe, he or she will immediately advise his or her coach or supervisor of such condition(s) and refuse to participate;
2. Acknowledges and fully understands that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, but also from inactions or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time;
3. Assumes all the foregoing risks and accepts personal responsibility for the damages following such injury, permanent disability or death;
4. Releases, waives, discharges and covenants not to sue the **USASA**, the **California Soccer Association North**, the **Monterey Peninsula Soccer League (the "League")**, affiliated clubs, their respective administrators, directors, agents, coaches and other employees and contractors of these organizations, other participants, sponsoring agencies, sponsors, advertisers and, if applicable, owners and leasers of premises used to conduct the event, all of which are hereinafter referred to as "releasees" from demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise.

I realize that by playing in the **League** I may be injured. I acknowledge that soccer is a sport that involves physical contact, perhaps of a violent nature. I acknowledge that games will be played on fields that contain holes, ruts, sprinkler heads and other hazards. I certify that I have no medical problems that could be aggravated by playing soccer or that could cause injury to others. I acknowledge the risks involved and, despite these warnings, I intend to play in the **League**. In consideration of the acceptance of my registration and the granting of permission to play, I hereby release, for my heirs, my assigns and myself:

1. The **League**, its officers, team captains, team managers, referees, referee coordinators, field coordinators, employees, representatives, and successors;
2. All Monterey County school districts, officers, agents & employees;
3. The Monterey Institute of International Studies, its officers, agents, and employees;
4. The State of California and the CSU Monterey Bay;
5. The Department of Defense and its departments, agencies, officers, and employees;
6. The California Soccer Association - North, Inc. and its affiliates;
7. The City of Marina, California; and
8. The Marina Coast Water District

from any and all liability or other claims I may make arising from personal injury, property damage, or other loss that I may sustain in connection with my participation in, or travel to or from, the activities of the **League**. If I make any claim or claims against the **League**, its officers, team captains, team managers, referees, referee coordinators, field coordinators, representatives, employees, or successors, I agree to settle said claim or claims for a total sum of One Hundred Dollars (\$100.00). I agree not to bring alcoholic beverages or illegal drugs to games played in the League. I agree not to drink alcoholic beverages or use illegal drugs while at the fields where games of the League are being played. I agree not to fight with any players or spectators immediately before, during or after games played in the League. The terms of this agreement are severable.

I have read the above waiver, release of liability and contract and understand that I have given up substantial rights by signing it, and sign it voluntarily.
